PLEASE ALLOW TWO (2) WORKING DAYS BEFORE CONTACTING THE COURT ABOUT YOUR CITATION

- **Form of Payment Accepted:** Cash, Check (pre-printed only), Money Order, or Credit Card
- **Credit cards accepted: American Express, Master Card & Discover only.** Payments made using a credit card will include a 2.5% convenience fee for processing.

WHAT ARE MY OPTIONS? You have the option of paying the fine, in which case it will go on your driving record. If you want to keep the citation from going on your record, you may choose to take a Driving Safety Course, or request Deferred Disposition. You must confirm your eligibility with the court before making application for either of these options. If you comply with the terms of the court, the citation will not go on your driving record.

HOW MUCH IS MY FINE? Refer to the chart on the back of this sheet for fine amounts. Contact the court for more details and Payment Plans (972) 442-6999.

NOTE: SPECIAL CIRCUMSTANCES THAT EFFECT ELIGIBILITY

- ✓ **If you are under 17** - You will receive a letter setting a court date to appear with a parent before the Municipal Court Judge to discuss your options.
- ✓ **If citation is for 25 mph or more above speed limit** - You are **not** eligible for the Driving Safety Course
- ✓ **If you have a CDL license** - You are **not** eligible for Deferred Disposition or Driving Safety Course
- ✓ **If you were speeding in a Construction Zone When Workers Were Present** (fines double - contact the Court for cost) - You are **not** eligible for Deferred Disposition or Driving Safety Course.

DRIVING SAFETY COURSE ELIGIBILITY (Moving violations only):

DO NOT TAKE COURSE UNTIL YOU ARE APPROVED TO DO SO BY THE COURT

- ✓ Must have a valid Texas Drivers License
- ✓ Must have valid vehicle liability insurance (With name printed on card)
- ✓ Must **not** have taken a driving safety course within 12 months previous to the date of alleged offense

Fees:

- ✓ \$144.00 State and Municipal Fees paid at time of application
- ✓ \$10.00 - \$12.00 fee to Texas Dept. of Public Safety for copy of Certified Driving Record
- ✓ Fee for TX State approved Driving Safety Course (price varies)

After request is granted by the Judge:

- ✓ You will receive a copy of the signed Affidavit in the mail advising that you may complete a State approved driving safety course (6 Hrs) within 90 days.
- ✓ Once course has been completed, return the signed "Court Copy" certificate of completion, and the certified copy of your driving record to the Parker Municipal Court at the address below.

DEFERRED DISPOSITION ELIGIBILITY:

- ✓ Must not currently be on deferred disposition for another offense in any Court in the State of Texas
- ✓ Must not have been on deferred disposition in the last 12 months

Fees:

- ✓ Must pay price of violation (see chart on back) at time of application
Copy of current ID or D/L may be required

After your request is granted by the Judge:

- ✓ You will receive a copy of the Order of Deferred Disposition defining the terms & conditions. Please read carefully and ensure you understand what is required for dismissal of your citation.
